## MESSAGE FROM THE MAYOR





Neighbors, you should be receiving this Reporter as cooler weather is inbound! This month will not have an infrastructure update to save space, but rest assured we are still working. The next Reporter will certainly have some big updates!

**High-Water Alert Lifesaving Technology** 

It has been a while since we have received a good rain but you will remember that there are several areas in Castle Hills that are still a threat. In our many conversations with Bexar County we discussed

the idea of the HALT System. The HALT System stands for High-Water Alert Lifesaving Technology. These are the flashing lights that you would typically see at low water crossings. Admittedly, the initial reaction was that these systems were a waste of money. It seemed rather commonsensical that if you saw water on the road, there is a problem. Well, it is never too late for us to learn. In conversations with Bexar County, we learned that part of the reason that these HALT Systems are so expensive is because they communicate with a network.

For our purposes, communicating with a network may appear to be relatively pointless. However, it can be very beneficial to our residents and guests, both short-term and long-term. The way that the systems work, there is a sensor that goes on the "upstream area" of the low water crossing. As soon as water is running over the road, it sends a signal to the flashing lights on each side of the low water crossing to catch a driver's attention that a hazard exists. This will be exceptionally useful in areas where it is dark and the low water crossing seams deceptively harmless.

But wait, there's more! The signs also communicate with the larger County network. You might ask why that is valuable. The status of the low water crossing is displayed on www. BexarFlood.org. Aside from showing the status to the entire County to keep people safe, it helps track historical data. Part of our challenge as a City is explaining just how little amounts of rain can cause hazards for people on Castle Hills streets. With the HALT System storing historical data we can better position ourselves for financial support from local, regional, and other partners to fix regional flooding.

The best part about the HALT System is that it is being done with ZERO upfront expense to the City of Castle Hills. The design and installation is being handled by Bexar County Public Works and the units are funded by a grant through the Texas Department of Emergency Management. The two areas that are scheduled to receive signs are at Krameria

right before West Avenue and Castle Lane between Zornia and Manton. These areas flow with sizable amounts of water and are high risk. There are a couple of areas on the border but those are positioned so that we could potentially partner with the City of San Antonio. Thank you to our partners at Bexar County and TDEM for helping keep Castle Hills safe!

### The Real Castle Hills

If you have Googled "Castle Hills" and seen a City that doesn't look familiar, you are not mistaken. There is actually a very nice community just outside of Dallas, called Castle Hills. This Castle Hills isn't an actual City but rather a suburb of the City of Lewisville. Several weeks ago, a colleague helped make an introduction to the Mayor of Lewisville, TJ Gilmore. Making the best of an existing work trip, we coordinated schedules and sat down to learn

about one another and our respective Cities. The Castle Hills community is very large and rather new. What was once the family ranch for the Bright Family (former owners of the Dallas Cowboys), has grown into a beautiful community with many great amenities. Mayor TJ Gilmore was very nice to spend an afternoon getting to know about our Castle Hills and sharing about the New Castle Hills.

The New Castle Hills has done a great job masterplanning all components of their development. Of particular interest was that they chose to really lean in to the medieval and castle theme. The community has many parks, all of which have adopted the medieval theme in one way shape or form.



**Advanced Policing Measures** 

As painful as it is for us to admit, our perfect little bubble of Castle Hills does have crime. While the City has done a great job of prioritizing advanced staff recruitment measures, we will never be able to hire enough Officers to stop all crime. In today's day and age, the question begs itself, how can we use technology to make our community safety. The answer MAY be a network of connected cameras. At our August Council meeting, Chief Zuniga brough forward an agenda item to discuss potential implementation of these cameras in or around Castle Hills.

Major kudos to your Council for taking an open-minded approach a relatively old style but new form of Policing. This is an old style in that, it is not a novel idea for cameras to be used in Policing. Police vehicles have been outfitted with cameras for more than the last 10 years, body cams have been in use in Castle Hills for almost 5 years, and for years Castle Hills had a Police Car outfitted with License Plate Reader cameras. What makes these cameras different you might be asking yourself. These cameras are what are referred to as LPR's or License Plate Readers. These cameras are on a nationwide network that is updated from the National Crime Information Center (NCIC). Under ideal circumstances, when a vehicle's license plate is scanned and it registers as a recognized plate, it will immediately notify Castle Hills Officers via their in car computer.

It is important to point out that this platform has a variety of public safety components. From recognizing stolen vehicles, to Amber Alerts, and even Silver Alerts; it will notify the Officers that a vehicle may be in the area. This system can also be useful in scenarios where your surveillance is unable

to capture the license plate of a porch pirate, mailbox thief, or any other type of burglar. This can give Castle Hills Police the info that they need to get a case going.


There is a lot to take in with new technology. Fortunately, your Council began to ask the hard questions with respect to privacy and safety to ensure if this something that we do, that it is being done right. For example, Council Member Alderman Smith was the one that asked about the time frame that data was stored. The Council seemed pleased to know that data is only stored for 30 days and is not sold. The implementation of the system will likely have a trial period before the City commits any dollars. As always, we welcome your feedback now and during the trial phase.

Our priority is making sure that we are giving you more and doing it in the best possible way. While it would appear that Castle Hills is ahead of the curve, the reality is that there are many Police Departments across the State that are exploring this technology; including the San Antonio Police Department.

We look forward to seeing you in the Commons soon!

### FY 2025 ADOPTED BUDGET

After two months and five meetings, the FY 2025 Adopted Budget has been adopted. The FY 25 Adopted Budget will now begin October 1, 2024, and end on September 30, 2025. As City Manager, it is my responsibility to provide a document which details expected expenses for the next fiscal year which includes anticipated revenue to meet these expenses.

As we have discussed, planned and have now executed, the 9-month FY 24 Adopted Budget will conclude on September 30, 2024. The goal to change our fiscal year has now come to fruition and this will aid the city in the future to better prepare, plan and monitor our city budgets moving forward. This is why the current FY 24 Budget is only a nine-month budget. A fiscal year that starts on October 1 would be aligned with property tax year collections. This is crucial due to property tax revenue being the largest revenue collected in the General Fund. An October 1 fiscal year would match the federal government. October 1 fiscal year runs in line with grant funding opportunities, including federal funding opportunities. Many cities around the surrounding area and the state have a fiscal year which starts on October 1.

As a result of the FY 2024 Adopted Budget, the City was able to address a number of areas related to services and operations including the modifications made to the City's retirement system. Similar to the budget process last year, we have identified future expenditures related to the use of the American Rescue Plan Act (ARPA) funding. We have also included the next steps to implement the FY 2025 major capital projects related to street and drainage as we continue our long-term improvements to the City's infrastructure. Over the last few years, we have taken necessary steps to improve our organization, its culture, its infrastructure, its communication process, and other internal improvements as a part of the annual budget. Last year, the City was able to complete another phase of street improvements (reconstruction) consisting of ten streets funded through the 2023 Certificate of Obligations (COs) series.

The FY 2025 Budget will address two more streets requiring reconstruction, this will be Phase IV. By the end of 2025, the City of Castle Hills will close out the \$10 Million category identified in the City's CIP for reconstruction of streets in under five years. We have also continued to address streets through our maintenance plan, which has addressed over thirty streets based on the maintenance plan established in 2019. The FY 2025 Budget includes further dollars from our Street Maintenance Fund to continue these efforts, including a mill/overlay project. The FY 25 Budget has \$300,000 from the Street Maintenance Fund programmed to address three streets (Amerson Lane, Castle Oaks Drive and Lemonwood

from Roleto to NW Military). Regarding drainage improvements, our next phase will involve a combination of drainage and street reconstruction projects, this will include North Manton and Carolwood Phase III to Lockhill-Selma. Both projects will be funded from the 2023 COs series.

The FY25 Budget is fiscally conservative and balanced. The General Fund is the largest fund for the City and accounts for the general service and operations (police, fire, permitting/planning, public works, and administration). All City employee salaries are funded out of the General Fund. The General Fund revenue budget totals \$8,367,219 and the expenses in the proposed budget total \$8,367,219.



The FY 2025 Adopted Budget maintains the core services such as Public Safety (Fire, Police and Dispatch), Public Works (sanitation/streets), Municipal Court and Administration. Above is a breakdown as it relates to \$1.00.

The FY 25 Budget does not include any additional personnel. Includes a 3.5% cost-of-living adjustment for employees. A 5% increase to the current cost of Health Care for City employees. An increase from \$51,098 to \$54,243 for the entry level Firefighter position for the Fire Department Also, included is .50 cent increase to the monthly residential rate for Sanitation Services (Landfill fees will change from \$46.13 to \$48.25 per ton). Funds are programmed from the American Rescue Plan, to provide funding for the Commons and Fire Department. ARPA related expenditures in the FY 25 Budget involves the installation of two pavilions in the Commons, further facility improvements at the Fire station including the replacement of the bay doors and a generator for Public Works building.

Every budget is an attempt to balance current and future needs within the framework of limited resources, and this year's budget has been constructed within those guidelines. The proposed budget sustains City operations/services, includes operational expense changes from the FY 2024 Adopted Budget to the Proposed FY 2025 Budget, incorporates our debt model and includes capital needs towards the continuation to bolster our City's infrastructure.

I wish to extend my appreciation to the City Council for attending Special City Council/Budget Work Sessions to date, reviewing budget documents, your leadership and continual guidance from the development to the adoption of the FY 25

Budget. I also want to express my appreciation to the entire City Staff, our leadership from the City's department heads for everyone's dedication and hard work in striving to maintain the highest level of service to the citizens and businesses of our community.

### **BRANDING CAMPAIGN UPDATE**

We are excited to let you know that Phase I of the Castle Hills Branding Campaign is completed. A huge Thank You to the Castle Hills residents, business owners and city staff who provided their input and guidance in a series of Discovery Sessions/Town Hall Meetings conducted by Creative Civilization. Creative Civilization is an Advertising/Public Relations agency in Castle Hills and is the agency responsible for the "Go Spurs Go" campaign and rebranding of CPS Energy, VIA and Opportunity Home.

After talking with officials from other cities in Bexar County and around the State, it had become apparent that our City needed a unified logo, tagline, narrative and brand guidelines in order to be competitive when it comes to attracting residents, enhancement of economic development and when applying for grants or other financing.

Additionally, the comprehensive plan adopted in 2023 outlined a priority to develop branding for our City, to convey to the outside world the special qualities and desirability of Castle Hills. The strategy could include a new logo, treatment of city entrances and highway overpasses, signage, and as otherwise recommended by the consultant.

Branding a city is more than simply creating a logo/slogan. It involves shaping the perception of a place, fostering civic pride, and attracting residents, businesses, and visitors to the community. Creative Civilization recommended two primary phases of the planning and execution process to be guided with the creation of a Master Marketing Calendar.

During Phase I, insights and direction from the community were sought that included core values, current beliefs or perceptions and branding goals. The direct engagement and collaborative approach yielded strong ideas and enthusiasm with stakeholder participants, including their preferences and recommendation for the new branding, all based on the core values, current beliefs or perceptions and branding goals. Creative Civilization then produced a number of examples of narratives, logos, and taglines and provided some examples of touchpoint applications for the logos and taglines – signage, shirts, name tags, mugs, caps, etc. There were more conversations and feedback from the session participants that resulted in the following recommendations that were

presented and approved at the City Council meeting on August 13, 2024:

and it appears the fall will be even busier - in the best way. City Council met during the summer to work on the annual budget (see the City Manager's report for more information). The Castle Hills Branding Campaign began in late May and included a number of "discovery sessions" and then reviews of possible end-products involving residents, business owners and city staff who shared their ideas and thoughts about our city. Councilmember Jack Joyce and I worked on this project with City Manager Rapelye and the Creative Civilization team. Hearing everyone's perceptions and ideas and the lively discussions during those sessions was interesting and fun. As the campaign moves into Phase II and the launch of the campaign, we're continuing to help coordinate the details. In July, I was part of project to distribute hand sanitizer to our area schools and city departments. Al Perales and his wife Karen moved to Castle Hills last year. Al had a long career in the technology industry and is now the Chief Commercial Officer for Austin Lighthouse, a non-profit organization that offers education, training, advocacy and community for blind and visually-impaired individuals in Travis County and surrounding areas. A fun "bunco night" in August sponsored by the Castle Hills Community Organization (CHCO) included lots of laughter, friendly competition, fun party foods, and connections among new and long-time friends. ## JACK JOYCE PLACE 4, Mayor Pro Tem

Friends and Neighbors,

As summer winds down, I'm pleased to note that the first phase of our Brand Evolution initiative is complete. My thanks to Councilwoman Haley for her great effort on this project. You should begin to see the fruits of this work as fall gets underway. Please see info on the project elsewhere in this publication.

I'd like to update you all on one of the more important aspects of our Economic Development effort, the creation of an incentive policy. An incentive is a monetary benefit that a municipality can provide to an individual or entity, usually a developer, who would like to invest in a property within the municipality. The premise is that the investment would add to the City's revenue, and so would be worth providing a benefit to the investor. These are normally given as tax breaks, grants or loans, all intended to encourage the investor to make the investment. The tax breaks are usually provided based on an assumed future value, so there is no reduction in current tax revenues. Grants, donations, or a reallocation of the City's sales tax are among the other options to fund the incentives. Note that a reallocation of the sales tax can take place only in an election. Many of our sister cities make use of the sales tax to fund economic development efforts, including incentives. Last month (July) the Economic Development Committee presented to City Council a draft of the proposed incentive plan. It was received enthusiastically and so the Committee is hard at work developing the details. They've proposed is a four-tier policy as follows:

Urban Renewal (Tier One). Create Tax Incentive Reinvestment Zones (TIRZ) to improve areas such as Jackson Keller between Blanco and West Avenue.

• Retail and Restaurant Support (Tier Two). Incentives for businesses that add significant sales tax or jobs, most likely restaurants and retail stores.

- Job Training and Education (Tier Three). Incentives for entities that provide workforce development or education for those in our area. Consider programs in culinary, cyber security, AI and other popular studies that could generate increased expertise in our City and thus encourage business to expand or relocate here.
- Storefront Beautification (Tier Four). Incentives for businesses that provide improved landscape, signage, or facades. Consider instituting architectural design guidelines to assure a minimum level of quality.

This should give the City lots of options to improve our City, thus assuring increased revenue and ultimately a higher quality of life for us all.

## CASTLE HILLS FIRE DEPARTMENT

Cooking and heating are the leading causes of home fires and fire injuries, and winter months are the peak time for firerelated incidents.

#### Minimize Your Risks

When cooking, make fire safety a priority by keeping these tips in mind:

- Stay in the kitchen while you are frying, grilling, boiling or broiling food
- When simmering, baking or roasting, check the food regularly, remain in the kitchen while cooking and use a timer
- Keep anything that can catch fire away from your stovetop
- Heating is the second leading cause of home fires. Follow these tips:
- Keep all flammables, like paper, clothing, bedding, drapes or rugs, at least 3 feet from a space heater, stove or fireplace
- Never leave portable heaters and fireplaces unattended; turn off heaters and make sure fireplace embers are extinguished before leaving the room
- If you must use a space heater, place it on a level, nonflammable surface, like ceramic tile, not on a rug or carpet
- Keep children and pets away from space heaters
- When buying a space heater, look for models that shut off automatically if the heater falls over

### Other precautions:

- Check all cords and replace any that are frayed or have bare wires
- Switch to flameless candles
- Keep matches and lighters high and out of children's reach in a locked cabinet

### Working Smoke Alarms Are a Must

- About three out of five fire deaths happen in homes without working smoke alarms. Smoke alarms are a key part of a home fire escape plan providing early warning to reduce your risk of dying in a fire. The National Fire Protection Association recommends you:
- Install smoke alarms on every level of your home, inside bedrooms and outside sleeping areas on the ceiling or high on the wall
- Keep smoke alarms away from the kitchen, at least 10 feet from the stove, to reduce false alarms
- Test smoke alarms monthly
- Replace batteries in your smoke alarm and carbon monoxide detector annually
- Replace smoke alarms that are 10 or more years old

### Make an Escape Plan

One home structure fire is reported every 88 seconds, according to Injury Facts. Once the smoke alarm sounds, a fire can spread quickly, leaving only a minute or two to escape. That's why it's so important to have a home escape plan. Start by drawing a map for your home and follow these guidelines:

- Plan two ways to escape from each room
- Make sure all doors and windows leading outside open easily
- Identify secondary routes: a window onto an adjacent roof or a collapsible ladder from a second floor window
- If you live in a multi-story building, plan to use the stairs never the elevator
- Designate an outside meeting place a safe distance from the house

#### Practice Your Plan

- Practice getting out with eyes closed, crawling low to the floor and keeping your mouth covered
- Practice closing doors behind you
- Practice how to "stop, drop and roll" if your clothes catch on fire
- Practice testing door handles to see if they are hot before opening them
- Teach children never to hide and how to escape on their own in case you can't help them

### When and How to Use Fire Extinguisher

Always put your safety first; if you are not confident in your ability to use a fire extinguisher, get out and call 9-1-1. The American Red Cross cautions you to evaluate the situation and ensure:

- Everyone has left or is leaving the home
- The fire department has been called
- The fire is small, not spreading, and there is not much smoke
- Your back is to an exit you can use quickly
- Remember the acronym PASS:
  - Pull the pin.
  - Aim low at the base of the fire.
  - Squeeze the handle slowly.
  - Sweep the nozzle side to side.




