Message From the Mayor


As we look forward to yet another wonderful year as a Castle Hills resident, I would like to summarize specific agenda items that our City Council approved in 2007 and those for consideration in the first part of 2008.

- Revision of our zoning ordinance created by the Zoning Review Committee and recommended by the Zoning Commission for council consideration expected in January 2008.
- Acquisition of our sewer system by San Antonio Water System (SAWS), expected to close in December,
 2007. In conjunction with purchase, a franchise agreement will be entered into authorizing SAWS to collect the sewer charges in exchange for a 2% franchise fee. SAWS will be responsible for the maintenance and upgrading the system.
- City Public Service providing decorative acorn style light poles through the city's approximately \$700,000 CIED (Community Infrastructure Economic Development) Fund. Initially, the light poles will be placed on N.W. Military Hwy. from Gardenview, north to Lockhill Selma, staggered 150' on both sides of the highway. They will also be installed in front of City's Municipal Buildings, at the intersections of Cas Hills and Blanco and at the intersection of Travertine and Jackson Keller. In the near future, council will consider West Avenue and the residential areas.
- International Bank of Commerce was selected as the municipal depository for the next two years (they have served our city over the last 12 years).
- Ordinance levying 2008 fiscal year ad valorem tax for the city at a rate of 0.425801.
- Engaged our city manager, Michael Rietz who has been with us since July 2007.
- A stucco and brick monument sign will be built at the intersection of Cas Hills and Blanco which will display an artist rendered iron tree which will illuminated. The sign was designed, at no charge, by MDN Architects.
- Contract renewal with Heard and Smith LLP for collection of delinquent taxes.
- Stately plaque to recognize current and former members of city council will be displayed on the wall
 of council chambers.
- Re-appointment, Douglas Gregory, as City Treasurer.
- Appointment, Douglas Gregory, as Mayor Pro Tempore.
- Appointment, Tom Davis, to fill the vacancy of Alderman Place 5 (formerly Robert J. Ford who resigned due to time constraints).
- Re-appointment of municipal court judge, Ramiro Estrada and alternate judge, Brother William Dooling.

- Re-appointment of municipal court prosecutor, Bernie Martinez and alternate prosecutor, Susan Kilgore.
- Re-appointment of public health officer, Dr. George Aitee, MD.
- Ordinance approved for the compromise and settlement of the pending litigation Castle Hills First Baptist Church v. City of Castle Hills, pending the U.S. District Court approval.
- Appointments to Architectural Review Committee for a two-year term; Steven Ackely (Chairman), Claudia Bankler, Joan Buerschinger, Sarah Burke, Walter vonNimitz and alternate members, Ben Vaughan and David Kellogg.
- Re-appointment to the Board of Adjustment for a two-year term; Bill Schluter (Chairman), Eunice Vandenbos, Bob Jones, Brother William Dooling, Ted Popp and alternates members, Kathryn Safford, Terry Warth and Rosemary Lewis (new appointment).
- Re-appointments to the Zoning Commission for a two-year term; Marc Schnall (Chairman), Walter Beuhler, LaVerne Japhet, Doug Lewis, Tim Turner and alternate members Douglas Steadman and Brad Boeckner (new appointment).
- Appointments to the Crime Control and Prevention District: Re-appointed Ted Popp and appointed new members Jack Joyce & Betty Chandler.
- First commercial Christmas decoration for our city, a 27' brilliant lighted Christmas tree displayed in The Commons (next to city hall). Plans to expand our city's decorations is in the 2008 budget.

Michael Rietz City Manager

It's hard to believe that it has only been five months since I started work with the City of Castle Hills. I am really starting to feel settled in. The staff and the

Council have been good to work with and I'm slowly but surely getting to know folks in the community. One of the hardest parts of this job is remembering the names of all the people you meet at the start of a new job, so thanks for your patience.

One of the first things I had to dive into was the 2008 budget. We have once again kept the amount of property tax revenue the same as the year before, resulting in a decrease in the tax rate to 42.5 cents per \$100 of valuation. Since 2005 the tax rate has declined nearly 8 cents.

In the coming year we will be taking a look at how to go about implementing the street improvement plan that the city engineer put together earlier this year. Every street in the community was evaluated by the engineer and the type of repair needed for each section of street was applied to a map. The main three types of repair are: crack and slurry seal, mill and overlay and street reconstruction. With the exception of the section of Lemonwood that was completed earlier this year, every street in the city needs some type of work. We will be holding two or three Town Hall meetings to inform and get input from the public in the Spring of 2008, so watch for the postcards for those meetings.

- Authorizing expenditures up to \$1,000 per residential lot from the Oak Wilt Fund to purchase replacement tree(s) for the residential lots at 216, 217, and 218 Prinz Drive affected by the oak wilt disease no action taken.
- Determining whether mosquito control will be provided by the City of Castle Hills – passed unanimously.
- Amending the FY 2007 Budget for the purchase of a projector, laptop computer, and a pulldown screen for the council chambers – passed unanimously.
- Setting a time, date, and place for a special meeting to discuss the Castle Hills FY 2007 and FY 2008 General and Special Funds budgets July 25th set, passed with three (3) votes, Council member Glass abstained.

August 14, 2007

 W. Evans upon his retirement for 33 years of service to the City of Castle Hills – passed unanimously.

- Resolution waiving the rights in a triangular piece of land at the southeast corner of South Manton lane and Northwest Military Highway – tabled.
- Appointment to the Board of Adjustment postponed.
- Proposed FY 2008 City Budget no action.
- Scheduling a Public Hearing for the FY 2008 City Budget and Tax Levy – motion by Councilman Gregory to set the tax rate at the effective rate of .425801 – passed unanimously.
- Mayor to order the draft proposal of the FY 2008
 City budget to be filed with the City Secretary and available for taxpayer inspection until the next regular City Council meeting to be held September 11, 2007

August 23, 2007

Consider and act upon:

 An ordinance approving a proposed consent decree to be entered in Cause No. SA 01 CV 1149-WRF, Castle Hills First Baptist Church v. City of Castle Hills, pending the United States District Court, which consent decree would approve and implement a compromise and settlement of the pending litigation and authorize the issuance of permits – passed 3 to 0; Council member Glass abstained.

September 11, 2007

Consider and act upon:

- Recommendations of the Zoning Commission for a Special Permit to conduct and operate a church from the existing building located at 2141 NW Loop 410, Zoned "H" Special Business District and to share parking with the adjacent property at 2013 NW Loop 410 – motion from Council member Huff to reschedule the item for October 9th.
- Annual health benefits plan for city employees passed unanimously.
- Acknowledging the proposed budget will raise more total property taxes than last year's budget by \$19,225 or 1%, and of that amount \$19,225 is tax revenue to be raised from new property added to the tax roll this year – passed unanimously.

 – passed unanimously.

- Consider and act upon a resolution authorizing use of CIED Funds for decorative street lights – passed 4 votes for and 1 abstention (Douglas Gregory).
- Consider and act upon an ordinance adopting North Central News as the official newspaper – passed unanimously.

FIRE DEPARTMENT Gerald Riedel, Fire Chief

Seasons Greetings to all!!!

It is my hope that everyone has a safe and joyous holiday season.

Starting in January we will be



initiating an aggressive campaign regarding the low hanging limbs in the streets and roadways of Castle Hills.

Low hanging limbs are a hazard to both emergency and sanitation vehicles. They are causing physical damage to the vehicles as well as causing obstructions to the clear pathways needed during emergency operations. Castle Hills City Ordinance # 13.503.3 subsection (c) "It shall be unlawful for any tree, shrub, states: vine, hedge, palm, or vegetation to be located, grown, planted, maintained or cultivated in such a manner that any portion of such tree, shrub, vine, palm, or vegetation may overhang or obtrude upon or over any sidewalk, curb, roadway, or pavement with the city or state right-of-way, unless there is a full twelve-foot vertical clearance between the surface of all portions of such sidewalk, curb, roadway, or pavement within the city or state right-of-way and the portion of the tree, shrub, vine, palm, or vegetation. The twelve-foot clearance must be maintained under all weather conditions and circumstances."

In addition sub-section (d) of the same ordinance states: that except for ground cover, neatly trimmed and maintained at a maximum height of 4 inches, it shall be unlawful to have any tree, shrub, vine, hedge, palm, or vegetation located, grown, planted, maintained or cultivated within a 5 foot radius from any fire plug within the city.

We are asking for your co-operation in these endeavors for the safety of all residents as well as city employees.

POLICE DEPARTMENT Donald Davis, Police Chief

Chief Davis has deferred his message to Officer Bret Wosnig

Once again it's Officer Bret Wosnig in for Chief Davis with some important information regarding the safety of our



children that I was previously unaware was taking place until I attended a "Teach the Teacher" presentation sponsored by The Bill Blackwood Law Enforcement Management Institute of Texas located at Sam Houston State University. Chief encouraged me to attend and upon my return we agreed that what I learned needed to be offered to the community at large.

GASP or Games Adolescents Shouldn't Play (GASPINFO.com) is about "The Choking Game". It is also known as "Space Cowboy", "Funky Chicken", "Flatliner" and "Blackout" just to name a few. The most frightening thing I learned about this game is that it requires nothing illegal to perform the act! It can be performed alone or with another person. It is fast becoming a deadly problem all the way down to the elementary level.

Basically stated kids these days, and even adults, are depriving their brains of oxygen by choking themselves, with various methods, or having someone else choke them to the point of unconsciousness. The person choked suffers seizures that cause permanent brain damage. Brain cells die each and every time. Outward physical harm comes to those being choked when the other person fails to catch the person as they fall.

The gaspinfo.com website is being updated but they do have a Flash presentation that will automatically play when you visit the site. It's only a few minutes long and will give you a better idea of what I have been talking about. Chief Davis and I are offering two (2) dates for the full presentation in January 2008. The tentative dates are both on Tuesday nights at 6:30 pm in the Castle Hills Municipal Building on January 15, 2008 and January 29, 2008 and will be 45-50 minutes in length.

This presentation is graphic and some of the information might be difficult for younger kids. 5th graders and younger might need to miss the first presentation on January 15th which is going to be as much like the way the presentation was taught to me. The second presentation on January 29th will be for all ages as low as first grade. We were instructed to tailor the program based on the

needs of the grade levels that we would be teaching.

CODE COMPLIANCE Rita Hoyl

NEW ORDINANCES

ACCESSORY BUILDINGS: Any accessory building larger than 120 square feet constructed to serve a single-or multiple-family structure subject to the foregoing 75% masonry requirement must also be constructed of masonry to the extent of not less than 75% of exterior overall wall area except that one (1) exterior wall, exclusive of openings, shall be constructed of masonry to the extent of not less than 25% of its exterior. Any accessory building larger than 120 square feet constructed to serve a single-or multiple-family structure not subject to the foregoing 75% masonry requirement must also be constructed of the same materials as the principal structure to the extent of not less than 75% of exterior overall wall area except that one (1) exterior wall, exclusive of openings, shall be constructed of the same materials as the principal structure to the extent of not less than 25% of its exterior. The exterior of an accessory building may not be constructed of sheet metal.

<u>AUTHORIZED DAYS AND HOURS OF</u> <u>CONSTRUCTION:</u>

Work activity, including, but not limited to, erection, excavation, demolition, or exterior alterations or repairs on any building or other structure, is restricted to the hours of 7:00 a.m. to 8:00 a.m. for work preparation activities, 8:00 a.m. to 5:00 p.m. for actual work activities and 5:00 p.m. to 6:00 p.m. for work cleanup activities and vacation of the site, Monday through Friday (except City holidays which may occur during the work week). Work activity, including, but not limited to, erection, excavation, demolition, or exterior alterations or repairs on any building or other structure, is restricted to the hours of 8:00 a.m. to 9:00 a.m. for work preparation activities, 9:00 a.m. to 4:00 p.m. for actual work activities and 4:00 p.m. to 5:00 p.m. for work cleanup activities and vacation of the site on Saturdays. Work activity is prohibited during other hours and on Sundays.

The City Manager is authorized to permit work activity for extended hours and on weekends and holidays for work that cannot be performed during the allowed hours and days of construction due to unusual circumstances that might be detrimental to the property, or for work that would, if delayed, be or create a hazard to public health and safety. The following work activity is exempted from the foregoing prohibitions: (a) any work performed by the homeowner or business owner without contracted labor or contracted assistance; (b) interior painting and exterior painting performed by a contractor; (c) work of any kind performed in an enclosed building by a contractor; and (d) landscaping related activities performed by a contractor (excluding earth moving and structural improvements, which are subject to the work activity limitation). This section does not affect any other prohibitions found elsewhere in this code, such as the prohibition against the creation of noise nuisances.

Animal Control



Are your pets current on their vaccinations? All domestic pets in Castle Hills must be registered with the City. Registration is only \$10. Please bring proof of current rabies vaccination for each pet.

STREETS, ALLEYS, DRAINAGE DITCH

Who is responsible for maintenance?

<u>Streets</u> – Public Works Street Department repair pot holes and crack seal. We replace traffic signs and street name signs.

<u>Alleys</u> – "Out of sight, out of mind"; this may be true for many of us. As with our lawns, *residents* are responsible for keeping alley ways free and clear of weeds, brush, shrubbery, or any vegetation greater than five inches in height to the center line of the alley. Overhanging brush can cause injury to our employees and equipment. Additionally, storing brush, tree limbs or any trash is not allowed unless it has been placed for collection in accordance with garbage regulations.

Public Works fills pot holes in alley ways as well. Excess water caused by draining swimming pools and allowing water from sprinklers to enter the alley cause deterioration of the alley. If you see water draining from a neighbor's yard into the alley, please bring it to their attention or call Code Compliance. While water is essential to our everyday lives, it is a detriment to our streets and alleys. Water produced by water leaks and rains cause damage to the streets and alleys by water seeping into the asphalt and traffic traveling over the openings causing the asphalt to begin cracking thereby creating pot holes.

<u>Drains</u> - During the past several months, we have spent many hours clearing debris obstructing the drain openings. Some of the debris removed consisted of dirt settlement, while much of the debris we removed was placed in the drainage ditch by residents or lawn service individuals. We removed piles of trash, leaves, tree limbs, logs, or bags containing brush. Not only is this practice prohibited by ordinance, but it can be avoided with your help. If you have excess brush, call me and I can offer a quote/surcharge to

have it removed from your property usually within 24 hours. If you are paying a lawn service to maintain your property, have them remove the bags or brush from the property.

Unless there is a holiday, brush service is provided to all residents each Wednesday. We will pick up the equivalent of three (3) 30-gallon cans per week. Do not mix brush with your household garbage.

BRUSH REGULATIONS

Trees and limbs cannot exceed three inches in diameter and five feet in length and should be stacked neatly on the ground if not in bags. Collectors will not service more than the equivalent of three 30-gallon garbage cans on any one call. Brush collection is provided once a week (except during a holiday week).

Do not mix garbage and brush in the same container.

FOOD NEWS



The City of Castle Hills has about 50 permanent food service facilities ranging from those selling only packaged foods and limited menu fast-food operations to full service restaurants and all you can eat buffets. In addition, a number of events such as school carnivals, fund raisers and business promotions are held each year with food vendors having temporary food service operations.

All of these food service activities are open to the public and must have a City Food Permit. The following three basic food safety principles apply to all facilities:

- (1) Food items and ingredients must be from approved sources. (Foods prepared in a private home are not considered as being from an approved source for sale to the general public).
- (2) Keep cold foods cold (at least 41°F or below) and keep hot foods hot (at least 135°F or above). Temperatures between 41°F and 135°F are in the Danger Zone and must be discarded after four hours.

(3) Wash hands before starting work and after handling raw foods, cleaning or visiting the restroom.

Don't worry about that backyard Bar-BQ you are planning for all your friends and relatives next month. This isn't a public event and you won't need a City Food Permit. But if you are planning to build a new restaurant, reopen an existing food facility that has been closed or just planning to sell hot-dogs at a fund raiser contact our Administrative Offices at (210) 342-2341 to see what type of permit will be needed.

Winter Averaging November 15th – March 15th

During this period, please be conscientious of your water consumption. Your new sewer rate will be based on a three month average water usage during this time. The more you use, the higher the rate.
