COUNCIL COMMENTS



MARCELLA HUFF, PLACE I, MAYOR PRO TEM



There are several ways that an item can become a city council agenda item. I would like to discuss several of those ways in this column.

Agenda items can be driven by federal or state laws that require some type of implementation on the municipal level.

Citizen concerns brought up during Citizens to be Heard may result in an agenda item several months later. Two examples of this are the recent ordinance governing bee-keeping and the one-way traffic during specific hours on Northcrest. Both of these topics were brought to the attention of the council over a period of several months because citizens were concerned about these issues or situations. The council directed further investigation by the city manager.

The city manager and department heads will discuss matters with the Mayor. Depending on whether or not council approval is needed the matter may be placed on the agenda. The need to designate a use for the CEID money from CPS was brought to council's attention by the city manager. This resulted in a presentation by a representative from CPS outlining the restrictions for using the money and the vote by council to use it for street lamps.

Council members may request an item be placed on the agenda. This may come about as a result of discussions with residents or concerns the council member may have over certain situations in the city. The council has felt that the city's building ordinances required review. A committee was established and as the ordinances are reviewed and revised they are placed on the agenda for council discussion and vote.

It is by attending council meetings and becoming involved in our community that we better understand the working of our government. It is easy to criticize the aftermath or outcome of any situation. It is much harder but also much more rewarding and productive to be a part of the solution.

DOUGLAS GREGORY, PLACE 2, CITY TREASURER



I want to first take the opportunity to thank everyone for re-electing me to another term as your City Councilman. It is a challenging job but one I greatly enjoy. I look forward to the next two years addressing your concerns and Castle Hills' future.

I want to return to an issue which still has not been addressed by your Council, i.e., the complete overhaul of our streets. The previous Council had all the tools needed to decide what to do. First, a bond counsel was hired, at no cost to the City, to help your City Council through the financial steps in the formulation and understanding of a bond issue. Second, the Street Committee, along with our City Engineer, carefully reviewed each street to evaluate what repairs were needed and with specific recommendations. Third, a citizen survey was conducted with many of you expressing your concerns as to street repairs. Finally the cost of money

(interest rates) had dropped to the lowest point since the 1930's. However, for whatever reason, a majority decided not even to put the issue on the ballot for consideration either last November or this recent May. Some on the Council feel we can patch the streets with the \$750,000 in our street repair fund but the reality is that many streets require major reconstruction work. Recently, it cost approximately \$230,000 to fix a *portion* of *one* street....and there are over 30 *miles* of road in Castle Hills. Clearly, we must consider borrowing the necessary funds to start a "Phase 1" of a long term street repair program. If not now, when?

Let me be perfectly clear, it will require raising our property taxes to start this needed internal improvement program; the exact amount would be determined by the amount borrowed. Contrary to popular belief, the City has borrowed money in the past for needed expenditures. Just a few years ago a loan of approximately \$500,000 was needed to purchase a very impressive fire engine.

So here we are. The streets of Castle Hills are in need of repair, some more than others. Two years ago, the overall cost was calculated in the area of \$30,000,000. The streets degrade every year and they will not fix themselves. At the very least, the City Council should put this issue up for a taxpayer vote. Up or down, we the taxpayer, must decide and the sooner the better. If not now, when?

Homeowner Responsible for Swimming Pool Maintenance

Homeowners are responsible for the maintenance of their swimming pool. When neglected, pool water can turn green overnight and provide a potential breeding area for mosquitoes. When neglected for some time the pool may become a breeding area for frogs. Tadpoles may even help to keep mosquitoes in check. Tragically the pool may now become an attractive nuisance for younger kids wanting to catch a tadpole.

Every year reports in newspapers can be found of children drowning in swimming pools. A swimming pool allowed to become an attractive nuisance can have the same result as a child playing with a loaded gun. A pool doesn't need to be breeding mosquitoes to be an attractive nui-

-sance. Even if a child climbs a fence and ignores a "Keep Out" sign, the pool owner may still face serious legal consequences.

When homeowners allow swimming pools to turn into green mosquito infested eyesores, it is a problem and a nuisance for the entire community. Already this season about a half dozen complaints has been received about green and neglected pools. When reports are received about a pool not being maintained, the property owner will receive a letter reminding them about the need to maintain their pool. When this doesn't work, other administrative and code enforcement measures will be taken, such as a summons being issued to appear in court.

STAFF COMMENTS

PUBLIC WORKS, Rick Harada, Public Works Director



This article is geared more towards Code Compliance and TREE TRIMMING issues than it is a Public Works issue. However TREE TRIMMING does affect the sanitation crew when it comes to brush removal. The rea-

son I'd like to talk about this is that I am driving the streets of our City every single day and I observe a lot of things that go on in the City throughout the day. If I see tree trimming taking place at a residence or place of business it is my job to call Code Compliance to confirm that a permit has been issued to the tree trimmer.

We try to make everyone aware of our ordinances, via our website, www.cityofcastlehills.com, or through our quarterly newsletter. For some reason or another, many of you still are not aware of our tree ordinance. Questions to ask before beginning any tree trimming are below.

First question to ask yourself when tackling a job, such as tree pruning is, do I need a permit if I am going to cut the trees myself? Answer YES, but you are exempt from paying a fee. If I hire a professional tree trimmer is a permit required. Answer YES; permit fee is \$50 for oaks and all other trees on the property to be trimmed, or \$20 if absolutely no oak trees will be trimmed. What if my landscaper trims the trees, is a permit required? Answer YES. Same fees above apply.

Next question, are cuts required to be painted on all oak trees. Answer YES, absolutely. Cuts on any oak tree must be painted within one hour of the cut. This is very, very important.

Next question, how do I dispose of the tree limbs. If you hire a private contractor, tree professional or your landscaper, it is their responsibility to remove limbs from the property within 48 hours after the job has been completed. If you personally have cut the trees, you can set out the equivalent of three 30-gallon cans each Wednesday. Do not set out anymore than this, because you may be sent a letter by Code Compliance for storing brush in the alleyway or curbside. I can also assist you with prompt removal if a surcharge is paid. Call me for a quote.

Next question, what if I or the contactor do the tree trimming without a permit? As with any work performed without a permit, you will be charged double the permit fee. Trust me, Code Compliance receives many reports about work taking place on the weekend that may not have been properly permitted. These reports are addressed on Mondays.

Finally, please comply with the tree ordinance. The large magnificent trees on your property is what make Castle Hills so unique. Make sure that permits are acquired and that the open wounds are painted within one hour of cutting. Don't leave those cuts exposed and risk the chance of infecting your trees with the oak wilt disease.

JOIN A NEIGHBORHOOD WATCH GROUP!

The key person in any neighborhood watch group is the block captain. This person is an integral component to keeping the block actively involved in crime prevention efforts as well as the important process of information exchange between neighbors. Many neighborhood watch groups flourish, but some dwindle while others disappear totally. How successful they are depends on the block captain and the support he or she receives from neighbors. The block captain should periodically monitor membership of your group. Contact new residents to get them involved and to obtain their support and participation. Update your membership list as needed. Contact Sgt. Mark Pardaen with Castle Hills Police Department if you have any changes to your roster. If you stop serving as block captain and/or if someone else takes over contact Castle Hills Police Department.

STAFF COMMENTS

Develop a neighborhood communication system to distribute vital information to neighbors pertaining to criminal activity and other concerns that develop in the area. This can be a periodic news letter, telephone tree, and or a one-page notice that can be distributed. You are encouraged to arrange for your group to meet socially several times a year to exchange information and renew relationships as well as get acquainted with new neighbors. People who communicate regularly will care more about each other and be more willing to keep an eye out for suspicious behavior.

Your position as a Block Captain does not give you any law enforcement authority. You are simply the person who facilitates the unity of the group, distributes information and coordinates activities. The job you are doing is important and appreciated by the Castle Hills Police Department.

Our recommendation to all citizens who see a crime in progress or notice suspicious activity is to observe and report from a place of safety. We strongly suggest that you not confront an offender unless you are in immediate danger. This applies to you and your neighbors. We do not want anyone to get hurt or injured trying to apprehend an offender or interfering with an incident other than to report the activity to the police. If you or your neighbors witness a crime in progress or observe suspicious behavior call 911 or the Castle Hills Police Department non emergency line 342-2341.

If you are interested in starting a crime watch on your block or want to become a Block Captain contact me, Sgt. Mark Pardaen with Castle Hills Police Department.

HEAT EXHAUSTION WARNING SIGNS



With the summer heat bearing down on us there are conditions to be aware of when working for long periods of time outdoors. Heat exhaustion is a form of heat-related illness that can develop after several days of exposure to high temperatures and inadequate or unbalanced replacement of fluids. Those most prone to heat exhaustion are elderly people, people with high blood pressure, and people working or exercising in a hot environment.

Warning signs of heat exhaustion include: heavy sweating, paleness, muscle cramps, tiredness, weakness, dizziness, headache, nausea or vomiting, and fainting,

The skin may be cool and moist. The victim's pulse rate will be fast and weak, and breathing will be fast and shallow.

If heat exhaustion is untreated, it may progress to heat stroke, which is a medical emergency. Seek medical attention and call 911 immediately if symptoms are severe, or if the victim has heart problems or high blood pressure. Otherwise, help the victim to cool off, and seek medical attention if symptoms worsen or last longer than 1 hour.

Heat exhaustion treatment

Cooling measures that may be effective include:

Cool, non-alcoholic beverages, as directed by your physician, rest, cool shower, bath, or sponge bath, an air-conditioned environment, lightweight clothing.


