JANUARY 10, 2012

Consider:

- Proposal to abate traffic hazards on NW Military Hwy no action taken.
- Resolution imposing an additional penalty on delinquent taxes for tax year 2011 and subsequent years, as provided by Section 33.11, Texas Tax Code, in the amount of 20% of the delinquent tax, penalty, and interest, if the tax becomes delinguent on February 1 of a year and remains delinquent on the 60th day thereafter – passed unanimously.
- Proposal for audit services from Armstrong, Vaughan, & city manager to sign an engagement letter - passed unanimously.
- Resolution honoring Richard Araiza on his retirement passed unanimously.
- Instructing staff to draft a new sign ordinance passed unanimously.
- · Appeal from Antonian College Preparatory High School requesting to install LED bulbs on the existing information sign at 6425 West Avenue - withdrawn from agenda by Antonian.



The advantage of living in a city the size of Castle Hills is that it is easy to get to know who holds elected office. Take advantage of this fact. I have always encouraged residents to get involved in their city. Attend council meetings, volunteer for a committee, board, or commission. Ask questions, make suggestions, offer constructive criticism.

2012 will be a busy year for our city. Although it may seem as though we just completed the 2012 budget, we must look ahead and start preparing for the 2013 budget process. Thinking about how the national and global economies affect our city is part of that process. I encourage all of you to take part in the budget process when it begins later this year. Attend at least one budget workshop and one public hearing. It can be an eye opening experience. Share your thoughts, ideas, and concerns with your elected officials. See what they think. Ask them to formulate their long term plans and goals for your city. Get involved.

Very little is asked of us as citizens. Obey the laws, serve on juries when called, and the greatest privilege of all: vote. Add one more to that list. Get involved at some level. It's in your best interest to do so.

Fiscal discipline. Two simple words that in today's economic environment mean a great deal. We are living thru some of the most economically dangerous times the country has seen since the 1930's. Because of this, city leaders must understand that every taxpayer dollar has to be spent carefully and on the strict discipline of preparing a

budget and sticking to it. The belief that you do not have to live within your means has gotten the Federal Government, many states and countless cities into serious financial peril. Unless a request for additional funds is for an unforeseen emergency, Castle Hills must remain disciplined and not cave into the desires those who want something that they could not get during the budget process. Like it or not, the age of "I want" must be replaced by "fiscal discipline". Hopefully, a majority of the Council will ignore the former and embrace the latter.

Being on the Council requires independent thought and action. Most, but not all, of your Councilmembers understand the importance of independence and not act as a simple echo of another member. But you, the public, have a responsibility, too. Come to the monthly City Council meetings, the annual

budget meetings and judge for yourself who is thinking independently; you might be surprised.

Last year the budget for Castle Hills passed by the slimmest of margins, 3-2. Councilwoman Huff and I voted against the proposed budget while Councilmembers McGuire and Howell reluctantly voted in favor even though they expressed valid reservations and because of artificial time restraints imposed by the Mayor. Councilmember Davis, in favor of tax increases instead of spending restraints voted in favor; the Mayor expressed similar expressions of satisfactions as Councilmember Davis, and was glad the process was completed. This is a completely unsatisfactory way to deal with the people's money. Fortunately at least four members of Council are looking forward to a better outcome for the taxpayer of Castle Hills in 2012.

Finally, as we move into winter then spring, Fiesta Castle Hills is gearing up for yet another event full of great music, food, vendors and Fiesta fun. The Fiesta Committee has been hard at work making sure that this April event will be great. Viva Fiesta Hills!!

For this City newsletter I thought I might take a few moments to discuss financial management philosophy. Whether it is my personal finances, my employer's

finances, or our City's finances, I always approach the decision in the same manner. First examine the need for the expenditure. Second research all of the various ways to accomplish that need. Third check to see that funds are actually available. Fourth since resources are always limited, prioritize the need considering all other needs to see if this is indeed the number one priority. And last allocate the funds. Unfortunately for many organizations the decision makers do not follow this rigorous process – rather they "fly by the seat of their pants" and instead jump immediately to fund allocation without considering the other issues. As a consequence best value is not always achieved.

So allow me to take a moment to expand. Too often we accept at face value that there is a legitimate need. But when you really analyze the situation, are all of the facts being considered? Does this need actually contribute to the mission statement of the organization? Are we continuing this process simply because we have always followed this process? Has a piece of equipment really reached the end of its useful life? Has technology truly moved far enough forward that old technology is no longer useful?

Second what other means exist to accomplish this need? For instance in medicine do we really need an ICU at every hospital or can we share resources between institutions? The same applies to City services – rather than each entity establishing its own independent service would it not be more efficient and higher quality to combine? We did exactly that for our paramedic emergency response, maintaining high quality service at half the cost. And we did this in January when I took the mandatory Texas Public Funds Investment Act training online rather than spend two days attending the course in Waco.

Third what are the financial resources of the individual or

organization? For example should you take a "pay day loan" or should you instead skip purchasing rodeo tickets or take a less expensive vacation? Using tomorrow's funds to pay for today's expenditures should always make you pause. And this includes bond issues and property tax increases — in both cases to some extent you are mortgaging your future.

Fourth is this need really the most important item on our dream list? I may wish to purchase a new 3-D flat screen but is this really more important than purchasing dance shoes for my daughter? Is having a top-of-the-line new car more important than repairing my roof? These same questions apply to every decision we make when we spend City funds — our resources are not unlimited. Once we exceed our resources the only options are to increase taxes or to take on debt. To me a need must truly be important before I will accept either one of these options.

Finally the easy part is spending the money. If you have truly followed the preceding process, you have no buyer's remorse. But if you ever find yourself asking why you did make some purchase, then you have already experienced the consequences of not being rigorous in your decision making process.

My belief is we on Council have an absolute obligation to you the Citizens of Castle Hills to be absolutely rigorous and meticulous in spending YOUR money. The money does NOT belong to the City or the Council. We owe YOU absolute transparency - you should readily be able to see exactly where your money has gone. And I believe you should be involved in the process - from the decision making to the accounting to holding Council responsible. I would encourage you to ask those hard questions of all of us on Council or of anyone aspiring to be on Council. Ask just how he/she will spend your money. What rigor will he/ she apply to the thought process? Make he/she justify every perceived need – does a need truly contribute to the mission of our City which is to provide services to our Citizens in a responsible, cost-effective manner? Or is the need simply an expedient way out of having to be more precise or having to truly consider the issue? And absolutely you must continue to hold your Council accountable not just during the election cycle but importantly throughout the year. Only with our Citizens fully engaged in our processes can we ever hope to receive best value for the dollars we collect from our Citizens.

secure your home is? The police will inspect your home and give you suggestions on how to improve your home security. They will even give you suggestions on how to form a neighborhood watch group.

Castle Hills firefighters will come to your home and identify potential safety risks and fire hazards. They are also available to speak to your club or organization on a variety of topics from your fire hazards to smoke detector.

When you acquired your Certificate of Occupancy, you also provided the police, fire and emergency medical services with a record of your home and who to account for in an emergency, including your pets you have registered with the city.

How about services like twice a week garbage pick up and once a week brush pick up? Not in San Antonio. Garbage pick up is once a week and it has to be placed in one gigantic container that average size people have trouble hauling out to the street (not the curb, but in the street). Miss a week putting it out? Too bad; wait until next week. Got too much garbage to put in the container? Go ask a neighbor if they have room because it must be in the single approved container. Brush pick up? Try twice a year. Castle Hills does much better than that. Oh, I know there are some that will say wait a minute. I had over the allowed number of leaf bags per pickup and I had to pay extra for my 30 bags to be hauled off by the city. Really? How much would you

have been charged had you called a private contractor haul them off? Castle Hills gives you a bargain for that once or twice a year problem. In San Antonio, no amount of money will get them to pick up your extra leaves and brush and haul them off. Twice a year and that's it.

Most residents are thrilled that they can call the city offices and actually talk to a person and not hear "If you have a question about permits, push 2 now." Or try calling San Antonio and asking to speak to the City Manager. Good luck. Yes, some Castle Hills residents are angry that they got the answering machine of this or that staff member. But if you left a message as requested, I'll bet you got a return call. Most staff even know your name and say hello when they see you. That only happens in small cities where the city staff personally cares about the citizens. Do they occasionally make mistakes? Who doesn't? However, on those occasions when things aren't done just right, rectifying a mistake is easy and usually swift in Castle Hills. Try getting an error corrected in a big city. They don't care. They don't have to because they're a big city and you're nobody.

This list of advantages could go on and on. I didn't even get into what a bargain it is for your city taxes. When you start hearing "We need to cut city services" or "We can contract out services cheaper," just remember that you get what you pay for. And yes there are those who feel we can eliminate this or that department and have a contract corporation, or a department of San Antonio or Bexar County perform the service for the city. Read my article in the City Newsletter last January and learn of the consequences suffered by cities that chose to contract out city services. As your Alderman, Place 5, and as a resident, I will always vote to keep our own excellent departments of police, fire and emergency medical, dispatch, public works, sanitations, municipal court and city administrative staff. That's a major part of what makes Castle Hills the city in which we have chosen to live.

ORDINANCE REMINDERS.....

§ 22.401 THROWING TRASH IN DRAINS PROHIBITED.

It shall be unlawful for any person to

throw or place any trash, brush, cut grass or weeds, debris or physical matter of any kind in, or on, any natural or artificial drain, drainage ditch, drainage easement, or stream, creek, or channel whatever in the city, or to permit the introduction of any such material into any such drain.

Why? Any foreign matter can cause an obstruction to drainage openings; thereby creating water to backup in the drainage way.

§ 22.402 BUILDING OF FENCE OR PLACING OF ANY OBSTACLE IN DRAIN OR DRAINAGE EASEMENT PROHIBITED. It shall be unlawful for any person to build or place any fence of any kind, or any other structure or physical obstacle in, on, or across any drainage easement, or any natural or artificial drain, or any stream, creek, or channel in the city, or any part thereof, without special permission from the City Council, evidenced by an ordinance duly passed, and then only in strict accord with the terms of such permission, if any.

Why? Such structure or fencing causes an obstruction to drainage ways; thereby creating water to backup.

§ 22.403 PROPERTY OWNER TO KEEP DRAINAGE EASEMENT CLEAN. It shall be unlawful for the owner or tenant of any property in the city which is traversed to any extent by an improved drainage easement to fail to keep such drainage easement on his or her property clean and free of all trash, brush, cut grass, weeds, debris, or other physical matter which is, or could be, an obstacle, to any extent, to the free-flow of drainage waters at all times without regard to the origin thereof.

Any foreign matter can cause an obstruction to drainage openings; thereby creating water to backup in the drainage way.

§ 28.103 WEEDS IN ALLEYS. It shall be unlawful for both the owner and the tenant of any property in the city abutting upon a public alley or way to permit any weeds, grasses, or other vegetation whatsoever to grow therein to the center line to a height of greater than five inches.

Why? Allowing weeds and/or shrubs to protrude into the alley causes injury to sanitation personnel and damage to vehicles.



Restaurants Recognized for Setting **High Standards**

The City has implemented the Texas Food Safety Star Certification program which is aimed at improving food safety in local food service establishments. This program is similar to New York City's Golden Apple Award used to recognize facilities going the extra mile for food safety.

To receive Texas Food Safety Star recognition a food service establishment must meet the following criteria; (1) Managers and Supervisors are certified in Food Safety Management and are able to demonstrate food safety knowledge and skills during routine evaluations; (2) have a written Food Safety Plan in place; (3) provide employees continuing training

in food safety; (4) continually exceed minimum food code requirements and; (5) conduct food safety self-evaluations. If requested, foodservice facilities will be provided assistance in establishing food safety plans and provided materials for use in training employees.

So far the following foodservice facilities have been awarded the Texas Food Safety Star Certificate in recognition of their outstanding food safety efforts: Rossini's Bistro; Picnikins Patio Café; Dough Pizzeria; Sushihana; Bandera Rd Café at West Ave; El Mana Bakery & Café; Zedric's; Demo's Greek Food; HEB Grocery; Jack-In the Box; Subway; Starbucks; Homewood Residence; Castle Hills Elementary School; and Jackson Keller Elementary School.

The following foodservice facilities are recognized for continually exceeding minimum food safety requirements: Sawasdee Thai Cuisine ; Garden View Café; El Palmar Cocina Restaurante; FlourPower Café' & Bakery; and Matter of Taste Catering. Once these facilities have developed a written food safety plan they will be eligible to receive the Texas Food Safety Star Certificate.
