Message From the Mayor Bruce Smiley-Kaliff

"City audit passes muster"

This month, I am completing my first year as your mayor, and I have just finished reading

the city auditors' preliminary report. I am very pleased with the audit, as I hope you will be.

For the first time in years, our city was legally compliant with state law regarding financial requirements, statements and audit requirements. This was largely accomplished by augmenting staff with a financial assistant, whom city council authorized after the last election. Another first in many years, was the city treasurer's compliance with state guidelines. This compliance was the result of Councilman McGuire having completing the training required by the state in January.

The city's quarterly financial reports were completed and signed as required by law due to the diligence of the city manager and financial staff. The city reduced its' long term debt by 18.9% and increased its general fund by over \$500,000. Our sales tax income exceeded \$1,300, 000, a new record for the city. The sales tax statistics are the result of all of the determination that

has been expended by citizens, staff and council to support our businesses and their owners.

It was acknowledged that the 2012 budget that was prepared by staff and approved by council is built around a property tax decrease of \$13,673 and the expenditures for 2012 have been reduced to a level which is only 3.5% over the city's spending levels of 2010.

This was done while maintaining all citizen services, giving our employees an across the board cost of living increase, maintaining the health benefits of our employees, funding our police and fire departments, public works and sanitation departments, animal shelter, Commons and our all-important 24 hour city emergency dispatch unit.

I believe this is an amazing accomplishment by all involved in this process including staff, council members who chose to participate and citizens who provided input. It is especially amazing since all costs of goods and services that

COUNCIL MEETING HIGHLIGHTS

FEBRUARY 14, 2012

Consider:

- Ordinance calling an election to be held on May 12, 2012 to elect three Alderman and addressing matters related to the election - passed.
- Joint election agreement with Bexar County for the May 12, 2012 General Elections passed.
- Resolution modifying the use of city owned vehicles for the Police Chief, Fire Chief, and Public Works Director passed.
- Resolution authorizing a car allowance for Police Chief, Fire Chief, and Public Works Director withdrawn due to action taken on prior agenda item.
- Repeal the second paragraph of subparagraph B.2.Agenda and add new language to the first paragraph of said subparagraph B.2. – this item will be placed on the May agenda for deliberation.
- Withdrawing from VIA and redirecting the proceeds from the 1/4% sales tax to the Castle Hills Street Maintenance Fund for the repair of streets and necessary drainage – no action.

MARCH 13, 2012

Consider:

- Policy for use of city owned vehicles modifications made to policy; passed unanimously.
- Amending Chapter 5 of the Castle Hills Code of Ordinances by adopting the 2012 Edition of the International Building, Residential, Plumbing, Fuel Gas, Mechanical, Fire, and 2011 National Electrical Codes and making amendments thereto – passed unanimously.



development. Although council cannot by law make comments or answers questions during Citizens to be Heard, rest assured they are listening to what you have to say. This issue has not yet been decided, so stay involved and keep making your feelings and concerns known.

Want another example that what you have to say is heard? Remember when the search for a new city manager was about to get underway almost two years ago? I was the lone council member who pushed for a search to find the best possible candidates to interview for the position. I proposed this because it is a sensible and good business practice. The way a city should be run. When citizens heard that the majority of council did not want to conduct a search the council chamber was filled at the next council meeting. The citizens on both sides of the issue expressed their opinions and concerns. Council listened carefully to what was said and then decided to approve a search for the best candidates to interview for the position of city manager. Once again, the citizens spoke and your elected officials listened.

While the decisions that are made may not always fall on the side that you endorse, be assured that your vote counts and when you speak your elected officials listen. At home, in Austin, in Washington. Never forget that.

There has been a lot of talk surrounding the proposed construction of a 4/5 story, 300+ unit apartment complex that might be built on the old Fink property behind H.E.B., fronting on Loop 410 with Gladiola St. on the reverse side. It is great that a developer has expressed interest in the

property but "the devil is in the details".

The time line of events is very odd. Apparently, two weeks prior to the February City Council meeting, an official looking letter which appeared to have the Castle Hills crest on top and signed by Mayor Smiley-Kaliff, went out to a select number of people for a "by invitation only" meeting with the developer. For some reason, Mayor Smiley-Kaliff specifically told our City Manager he was "not invited" and as it turned out neither was most of the City Council. Why? Why did Mayor Smiley-Kaliff

exclude the City Manager? Why did Mayor Smiley-Kaliff deliberately keep the City Council in the dark? Why was this "very important" meeting with the developer kept secret except for a favored few? As a developer himself, Mayor Smiley-Kaliff should realize that a project of this magnitude should be open and above board not "by invitation only".

The next week, the developer went before the Zoning Commission to ask for major zoning changes on the property. At the time of this request, the developer had not secured financing for the purchase of the land and was not the owner. However, the developer came unprepared and lacked answers to many questions such as 1) Had there been a study to determine the effect on the sewer system if there were 300+ new hook ups? 2) Had there been a traffic impact study to determine what hundreds of new cars would have on the surrounding streets? 3) How would this massive new development impact the creek running on the property line; would erosion increase? These and other questions were left unanswered.

If the Zoning Commission voted favorably for the request for rezoning, it would have been virtually impossible for the City Council to reverse the action



because rules require that a "super majority" of the Council members voting, to reverse a Zoning Commission vote. In the end, the Zoning Commission voted 3-1-1 against the proposed zoning change. One week later, the City Council was to vote up or down on the Zoning Commission vote but the agenda item was pulled.

I am sorry that the developer was under the impression that a 4/5 story, 300+ unit apartment complex could be approved without a careful and thoughtful process. When this property is eventually developed it must be a huge plus for the neighborhoods on and near Gladiola, vastly improve the Southern part of Castle Hills and bring in hundreds of thousands of new tax dollars. By having a "by invitation only" meeting and trying to ram through in two weeks a huge zoning overhaul on a large new development, there remain many more questions than answers both from the developer and Mayor Smiley-Kaliff.



Steve McGuire, PLACE 3, City Treasurer

Once again I am discussing what I consider our most significant issue – fiscal responsibility. For the three years that I have

served as your Alderman, I've struggled to understand why our sister city Shavano Park can deliver essentially the same services for 10-15% less cost (see http://www.shavanopark.org/2011-2012 Adopted Budget; http://cityofcastlehills.com/adopted city budget 2012). I can state unequivocally that (1) our employees are highly productive, (2) our employees definitely are NOT over paid, and (3) our department managers do an excellent job of managing daily expenses.

So why are our expenditures more? It comes back to what I discussed in my last newsletter – defining our needs. We are very good at identifying new needs and selecting the most cost efficient solutions to meet those needs. However once a need is established and a process is put in place, we maintain the status quo – forever! We fail to periodically reassess the continuing necessity for a need, to adopt changing best practices and changing technology, or to leverage our limited assets through mutual sharing with our surrounding municipalities. As a result we spend more than we should, more than the apparent benchmarks set by similar cities.

For a visible example of the consequences simply look at our streets (and perhaps compare to Shavano Park). Our City Engineer tells us we need approximately \$25 million in street repairs. Our City Bond Agent tells us a 20 year bond will increase our City property (ad valorem) taxes by about 50-75%. Our City Engineer notes that the life expectancy of some of the road repairs is 8-10 years. Clearly we need to repair our streets. However should we be paying for all of these repairs with a 20-year bond issue or perhaps pay for some of these repairs out of current revenue? But without addressing our inefficiencies, we lack current revenue for these shorter lifespan repairs.

The way forward is both simple and difficult. The inertia of status quo can be immense. We have the expertise within our City to modernize if we have the vision, the commitment, and the courage. In this my fourth year on Council my intent is to remain focused on our future. We can indeed modernize, becoming more efficient in the process, while simultaneously providing for 100% of our employees as we change. I ask you to join with me in this commitment – help me bring Best Practices to our City.

One cost saving measure favored by a Council Member is the repeated desire to eliminate the garbage collection in favor of a private company. This time the argument is that since the sanitation department has vacant unfilled job positions, now would be the best time to close the Department. This particular idea has been floating around for a couple of years. The City manager looked into it, and found that only minimal money would be saved by contracting with a private company providing once a week garbage collection rather than continuing with the garbage and brush pick up services we currently enjoy. After a city has disposed of its trucks, phased out the personnel, and the contract needs renewing, guess what? Cities that have chosen this option found that the contract price went up significantly leaving the city no choice but to renew at the more expensive contract rate. Another plan was to have the City pull out of garbage pick up completely. Under this plan, the resident would be billed directly by the garbage company. Does it save the City money? Does it reduce your tax burden? You bet it does because the City just passed the entire direct cost on to you, the resident.

Here's my personal favorite bizarre cost saving measure that's been discussed with me. With so many San Antonio Fire Stations around Castle Hills. let's eliminate our Fire Department and contract with San Antonio. We also could get rid of the Emergency Medical Services and have Arcadia handle those needs. Fire Stations are located by the population density of the specific surrounding areas. Do you really think San Antonio would be interested in adding more responsibility to a larger area without adding more shifts, personnel, and equipment? How much do you think San Antonio would charge Castle Hills for that expansion? The service certainly wouldn't be free. Would the response time be as fast? Save the City money? Really? What are some Council Members thinking?

How about this one? Since Castle Hills is so small, why not consider having the Bexar County Sheriff's Department be contracted to handle our patrol and police needs? Interesting. How much would they charge? Cost savings? Not really. In the last two January issues of the City Newsletter I related what happened to cities that tried this option. With the increase in police response time, the only ones who liked the change were graffiti artists and criminals.

Don't think the Animal Shelter hasn't been considered. In the last two budget workshops, the cost of the Animal Control Department has been questioned both in terms of direct costs and manpower issues. Our no kill Animal Shelter is where your beloved pet(s) will be taken when lost or found out of their yards. Every attempt will be made to return your little family member. If we give up our Animal Shelter your four legged loved ones would go to a San Antonio pound. You must locate where they have been sent and retrieve them in a specific amount of time or they will be gone forever. Also, what department do you think picks up dead animals in our streets and our city? Not your City Council Members.

So let's recount. The City of Castle Hills is not responsible for providing water or managing sewage disposal. If the City abrogates the functions of Police, Fire, Sanitation, Animal Control, and providing access to Public Transportation, what's left? A City Administration that simply processes contracts with other providers. Wow! That does save money. A staff of one or two could easily handle a city like that. Or maybe we should just let San Antonio annex Castle Hills -- don't think that hasn't been bandied around. One misinformed Council Member thinks San Antonio has lower tax rates. I guess that's what happens when you miss Council meetings.

Hopefully all of you got through our numerous rain storms safely and were able to enjoy Easter or Passover with family and friends.

I would like to thank all of the volunteers- especially Mr. and

Mrs. Richard Huizar- and the City employees, who worked so hard to make this year's Fiesta Castle Hills the best Fiesta ever. Also, thanks to the Homeowners' Association for putting on another great Easter Egg Hunt in the Commons.

In my last message, I referred to paving and drainage projects around the City getting underway this summer. The status of these projects is that the preliminary engineering has been completed. All of the utilities (such as water, sewer, electric, phone and cable companies) affected by these projects have been notified. In instances where the utility will have to be moved or modified in any way to complete the proposed project, meetings were held to find the best solutions. The City Engineer will be presenting his findings on all of these paving and drainage projects at the May 8 meeting of the City Council.

Homeowners should be aware that BexarMet (soon to be SAWS) will be conducting fire hydrant testing in the near future. Sometimes when fire hydrants are shut off, the resulting water hammer can shake loose rust or buildup from inside the pipes. Should you discover that your water has a slight brownish tint, simply run your water for a short period of time- preferably on your yard plants- until your waterline clears.

Thanks to all of you who keep your yards and property so well kept and also to those of you who volunteer to do so much to keep our City so beautiful. Take a moment to enjoy the beauty, which our recent rains have brought us before the heat of summer arrives.

Suddenly it's Spring! It seems like yesterday that it was Winter. With the precious rains we so badly

needed our lawns are requiring extra attention. Spring is the time we associate with planting colorful foliage, trimming shrubs, painting and simply tidying up the outdoors. And let's not forget the indoors. We clean out our closets, drawers, cabinets, garages, etc. So now how do you properly dispose of this? Some items you can donate to your favorite charity. Some items aren't salvageable and just need to be thrown away. Because this isn't regular household generated kitchen garbage, you shouldn't put it in the garbage cans for regular pick up. You may have hazardous pool chemicals or other materials that cannot be mixed in with your garbage. Call me at 342-2341, ext. 206 and I can provide you with a quote/surcharge to remove it from the property and properly dispose it for you.

How about tree trimmings and leaves? Brush collection is on Wednesdays of each week, except during a holiday week. How much can be set out? If the work was performed by a hired contractor or landscape company they must remove it. If you performed the work yourself, you can set out not more than the equivalent of three 30-gallon trash cans for collection. This does not mean they have to be in a trash can. Tree limbs can be neatly stacked, but cannot exceed 5' in length and 3" in diameter.

Remember, your household generated garbage must be placed in a bag and inside a trash receptacle. I've received calls that a trash bag was placed next to leaf bags and not picked up. The sanitation crew is picking up the bagged trash in cans and they do not open the bags to determine if the bag contains leaves or trash.

One more reminder. It is the property owner's responsibility to maintain any property abutting a public alley or way and to prevent any weeds, grasses, or other vegetation whatsoever to grow therein to the center line to a height greater than five (5) inches. Recently we had an incident that caused damage to our garbage truck due to overgrown bamboo in the alleyway. Luckily the collector on the truck was not injured. Please keep a clear path in the alleyway for "your" collector.

I found this important information while reading a nearby Homeowners Association news article.

10 THINGS YOUR BURGLAR WON'T TELL YOU

- 1. Yes, I really do look for newspapers piled up on the driveway. And I might leave a pizza flyer in your front door to see how long it takes you to remove it.
- 2. If decorative glass is part of your front entrance, don't let your alarm company install the control pad where I can see if it's set. That makes it too easy.
- 3. I always knock first. If you answer, I'll ask for directions somewhere, ask to clean your gutters, or ask for someone who I know does not live with you.
- 4. Do you really think I won't look in your sock drawer? I always check dresser drawers, the bedside table, and the medicine cabinet.
- 5. Your right: I may not have enough time to break into that safe where you keep your valuables. But if it's not bolted down, I'll take it with me.
- 6. Sometimes, I carry a clipboard. Sometimes, I dress like a lawn guy and carry a rake. I do my best to never,

ever look like a crook.

- 7. The two things I hate the most: loud dogs and nosy neighbors.
- 8. I'll break a window to get in, even if it makes a little noise. If your neighbor hears one loud sound, he'll stop what he's doing and wait to hear it again. If he doesn't hear it again, he'll just go back to what he was doing. It's human nature
