**The City of Castle Hills City Council will convene into an executive/closed session to consult with the City's attorneys as authorized by Section 551.071 (2) of the Texas Government Code to discuss traffic impacts on residential streets by large institutions because the duty of the City's attorneys to the City Council under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Open Meetings Act.**

**The City Council will reconvene in open session.**

**III. The City Council will consider and may take action to amend certain sections of Chapter 8 of the Code of Ordinances which regulate traffic impacts.**

**IV. Executive Session.**

**The City of Castle Hills City Council will convene into an executive/closed session to conduct a performance evaluation of the city manager as authorized by Section 551.074 of the Texas Government Code.**

**The City Council will reconvene in open session.**

**V. The City Council may take action resulting from the performance evaluation of the city manager.**

**VI. Adjournment.**

*The City Council reserves the right to retire into Executive Session whenever it is considered necessary and legally justified under the Texas Government Code, Subchapter D, Sections 551.071 et. seq. including, but not limited to, consultation with attorney, real property, prospective gifts, personnel matters, exclusion of witness, security devices, and economic development matters.*


