QUALIFICATIONS FOR JURY SERVICE (GC Section 62.102 except where noted)	EXEMPTIONS FROM JURY SERVICE* (GC Section 62.106)
<p>To serve as a juror you <i>must</i> meet the following qualifications:</p> <ol style="list-style-type: none">be at least 18 years of age;be a citizen of this state and a resident of the county in which you are to serve as a juror;be qualified under the Constitution and laws to vote in the county in which you are to serve as a juror (<i>Note: you DO NOT have to be registered to vote to be qualified to vote</i>);be of sound mind and good moral character;be able to read and write;not have served as a juror for six days during the preceding three months in the county court or during the preceding six months in the district court;not have been convicted of theft or any felony; andnot be under indictment or other legal accusation of a misdemeanor theft, felony theft or any other felony charge.be a resident of the municipality for which the Court is established. (GC Section 62.501;) <p>NEW ADDRESS:</p>	<p>You <i>may</i> be excused from jury service if:</p> <ol style="list-style-type: none">you are over 70 years of age;you have legal custody of a child or children younger than 10 years of age and service on the jury would require leaving the child or children without adequate supervision;you are a student at a public or private high school;you are enrolled and attend college;you are an officer or an employee of the senate, the house of representatives, or any department, commission, board, office, or other agency in the legislative branch of state government;you are the primary caretaker of a person who is an invalid unable to care for himself or herself (This exemption does not apply to health care workers.);you have served as a juror in the county during the 24-month period prior to the date you are required to appear for this summons;you have been summoned for service in a county with a population of 250,000 and you have served as a petit juror in the county during the three-year period preceding the date you are to appear for jury service;you are a member of the U.S. military forces serving on active duty and deployed to a location away from your home station and out of your county of residence. <p>* You are not required to <i>claim</i> an exemption, but if you do, you must mark which exemption applies to you.</p>
