The voter-approval rate is the highest tax rate that CASTLE HILLS, CITY OF may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CASTLE HILLS, CITY OF is proposing to increase property taxes for the 2024 tax year.
